CALL TO ORDER

Michael informed the meeting that he and Kelly attended the ceremony for the opening of the pool by HRH Prince Charles of Wales.

Michael informed the meeting that 400 people were present for the opening of the pool and was very well attended. It was a lovely ceremony. The changing rooms and bathrooms will be along the pool and the construction has been delayed due to the visit of the Prince and Duchess of Cornwall.

There is a plan later in the year to have a Lions and a high school meet. The date has yet to be determined. Currently it is believed that the Brac has about 200 swimmers.

The pool has timing equipment and the timing shed is airconditioned.

SPECIAL OLYMPICS

TECHNICAL DIRECTOR'S REPORT

Bailey informed the meeting that the Artistic Swimming Chaperone will be the coach from Barbados. Background checks have been conducted for her to be the chaperone.

Trailer has been ordered by Steve and is being shipped here with the Flowers container.

Any other Business with Club Representatives Present

SMS

Dean updated the meeting verbally

There are 24 swimmers going away to Fort Myers and 6 swimmers going to CARIFTA and one declined to go to CARIFTA.

There were 28 swimmers at Nationals.

CBAC

Andrea updated the meeting verbally.

There is nothing new to report on the transition from Dart. The Spring Splash meet taking place for the U10 on Saturday 6 April 2019 is not a sanctioned meet and will be a fun meet. It is often an introductory meet for young swimmers.

SSC

Lynn tabled the Stingray report.

Stingray would like CIASA to help speak to government about the lane lines. The lane lines are at the end of its course and need to be replaced. One lane line costs CI\$630.00 (times 5). It was recommended that someone approach Ryan about the subject and CIASA will happily participate in facilitation. Ryan is employed by the government and has access to the senior staff dealing with the Lions pool.

Bailey suggested that the child protection officer for Stingray be revisited and it should be a parent who is around the meets and some of the practices.

Queries from Stingray:

Currently the CIASA child protection officers are Michael and Bailey. Stingray queried if there have been any updates on the pilot program. Answer: CIASA has not had any updates.

Query on Officials training: Answer: Technical committee organised clinics in March 2019 and were well attended.

Query: Unclear on who Team Manager was for CARIFTA 2019 and query on why the chaperone position came about. Answer: Staff were chosen, and roles appointed a little thereafter. Chaperone position came about from discussions last year where it was decided that depending on the number of 11-12 swimmers, CIASA would consider taking an extra chaperone.

Query: cost of CI\$25 for the Leadership clinics; was it to cover a shortfall in sponsorship and monitoring of payments? Answer: The CI\$25 was a token amount to cover the costs of bringing our lecturers down.

It was queried whether there would be team handbook and on when the CARIFTA 2019 would be announced officially.

This year RTC has included many items from the handbook in the RT Agreement and once the team gear arrive, the team will be announced officially.

The club representatives left at 7.30pm.

TREASURER'S REPORT / CIASA BUDGETING

Representative Team Committee

Discussion then continued to Water Safety Date taking place on 18 May 2019 and ideas regarding promotion of water safety in the community. Chilian suggested taking half or quarter of a page in the Compass to promote water safety.

Fund Development

We have confirmation of the CI\$3,000 from Deloitte

Katie discussed the possibility of creating a tiered system for sponsors.

Katie is working with Sandy and the Booster committee for the golf tournament and using this to drive sponsorship.

Katie informed the meeting that the government reviewing application for the CARIFTA grant from CIASA.

Sandy informed the meeting that the CARIFTA Gear is on its way.

The Games and movie fundraiser is still being worked on.

Facilities

Steve updated the meeting with a verbal update.

Steve has been liaising with USA Swimming with regards to the design of the aquatic centre. We are also getting prices for the stainless pool. Mick Nelson is reviewing the plans. We have asked Myrtha pools for a competitive quote. We already have one quote from Astral. Steve informed the board that we are also looking at companies in the US who have dealt with the planning and building of aquatic and sports centres of this calibre.

Michael informed the meeting that the cricket association has been offered acreage close to the Agricultural Grounds in Lower Valley. Ken Hall has donated land for the new cricket facility. More land might be available for other sports.

Steve brought up the lack of bathroom facilities at Governors Beach and would like to know if the public works department should be contacted with regards to having proper bathrooms and toilets by Governor's beach.

The update is that Brett Fraser is back and in training and is hoping to qualify for the bigger international meets coming up.
