CALL TO ORDER

Steve called the meeting to order at 6.31pm.

MATTERS ARISING

PRESIDENT'S REPORT

There were no updates.

SUB-COMMITTEE REPORTS

Flowers Sea Swims and Open Water

Duke confirmed that the first Flowers sea swim meeting has taken place. .

ANY OTHER BUSINESS:

These two topics were raised for discussion with regards specifically to CIASA national championships:

- 1. Scratches and non show up:
 - a. If a swimmers scratches from the meet, the system should scratch them from the heats for the whole meet. The answer to that is that in theory this should definitely take place, the reality is the lack of time lag given to do so in the computer and re do the heats.
 - b. If a swimmer scratches from a final after prelims, how should that be treated? Should they de penalised /disqualified from the next event unless there is a valid reason?
- 2. How do timed finals work? The rules about timed trials should be more definitive in the summons
